"Highways Division Haveli" Communication & Works, Govt. of Azad Jammu & Kashmir invites Electronic Bids in accordance with AJK P.P.R.A Rules 36(a) for a Single Stage-Single Envelope Bidding Procedure from the eligible Firms/Contractors licensed by the Pakistan Engineering Council and having endorsement in C&W Govt. AJ&K for the following works...

- 1. The newly registered bidders are directed to get user names and login details from IT Section, Office of the Chief Engineer Highway (North) Block H, DHO Muzaffargarh. Bidders/Firms which are already electronically registered with the Department can use already provided username & password.
2. Bidding Documents and instructions to Bidders can be downloaded from Contractor's E-Bidding Dashboard.
3. Interested bidders will have to submit their bid before due time mentioned in Column no 07 above & will be opened as per schedule time in same column 07, the comparative statement will be visible to the Bidders or their nominated representatives & Bid Opening Committee.
4. The interested bidders shall upload scanned copy of Bank Receipt showing proof of deposit of Bid Security in the Divisional Joint Account, A/C # 038-12548001 BAJK Haveli (Kahutta) Branch along with their relevant documents on its Dashboard.
5. The bid securities of unsuccessful bidders will be returned through Divisional Cheque upon award of the contract to the successful bidder(s) or on the expiry of validity of bid, whichever is earlier.
6. Electronic Bidding shall be done on percentage (Above/Below/At par) Basis. Only Two digits after the decimal point shall be considered for evaluation purposes.
7. Blacklisted Firms/Contractors/Companies/Suppliers/Distributors are not allowed to participate in the bidding process. The interested bidders shall furnish an affidavit/certificate that they are neither blacklisted nor involved in conflict with Govt. anywhere in territory of the state of AJK or Federally administered areas/all provinces of the Islamic Republic of Pakistan.
8. Hard copy of Original Bank Receipts along with Bidding Documents (uploaded by Highways Division Haveli duly signed & stamped by the Contractor/Firm) must be submitted in the relevant office of the Executive Engineer Highways Division Haveli within 48 hours after opening of bid in E-Bidding system.
9. The interested bidders shall upload only Letter of Bid of the Firm/Contractor, other documents required for qualification/responsiveness as per Bid Data Sheet and BOO on E-Bidding Dashboard. The remaining data/particulars shall be submitted in shape of hard copy along with uploaded pages within 48 hours after opening of their bid(s). Otherwise such bidder/bidders will be declared as disqualified.
10. In E-Bidding system, the software supports only PDF file format for Technical Profile uploading option.
11. Any Bidder(s) who provides incorrect information or does not submit hard copies of complete bidding documents including documents uploaded on its dashboard shall stand disqualified and shall be banned for two years for participation in any type of bidding procedure.
12. The competent authority reserves the rights to reject all or any bid under this Clause 33 of AJK P.P.R.A. Rules.
